Location: Horsielands Farm, Church Lane, RH5 5DP

Proposal: Demolition of the existing buildings and development of 3 no detached houses

with associated parking, landscape and access.

The Parish Council would like to make the following comments on this application.

Under the original approved planning application MO/2023/0940, Condition 4 required the developers "to improve the public highway by providing a lit and paved pedestrian/cycleway". The Councillors do not feel that the addition of <u>any</u> artificial lighting to the development would be in keeping with the rest of the village. Newdigate has no street lighting, and its addition would have a negative impact on the wildlife at night and would dramatically alter the current rural feel to the surrounding neighbourhood. We would strongly ask that this condition be removed and redrafted to restrict the level of light pollution to the existing community.
